

## Application to conduct doping tests with WORLD SKATE (WSK) as Test Authority and Results Management

#### Athletes from more than one country competing

Tests involving International athletes will usually have WSK as results management.

#### Athletes from one country or National Federation Competing

For controls which involve athletes of a National Federation only the NADO will be the Results Management aurhtoity. In this case the NADO will be responsible for selecting athletes to be tested and allocation of the testing menu and WSK will not be involved.

#### National Federations, Continental areas and affiliates ordering tests under WSK

All National Federations, Confederations, Discipline and Branches who wish to test athletes where WSK is the test authority (TA) and Results Management Authority (RMA) must notify WSK of the test distribution plan in advance and forward a copy of doping control forms (DCFs) to WSK office within 5 working days.

#### Testing Menus for All WSK tests & organisation

All controls must be in compliance with WADA international Standard for Testing, FIRS Anti-doping Policy and the <u>Technical Document for Sport Specific Analysis</u> (TDSSA) menu.

An accredited sampling agency is to be used and the Federation co-ordinator must appointed as the WSK test co-ordinator to ensure the doping control officer (DCO) allocates the test to the correct discipline on the DCF and paperwork for the WADA accredited laboratory.

#### Administration of Tests ordered under WSK

A test co-ordinator must be appointed prior to the tests and notified to WSK

#### The appointed WSK test co-ordinator will be responsible for

- Communication with WSK doping control manager and WSK office
- Provision of suitable facilities for doping control and adequate sealed drinks for athletes
- Ensuring all rules of International standards of testing are adhered to
- ➤ Athlete selection in accordane with Test Distribution Plan (TDP)

- ➤ Ensuring that WSK is the test authority and results management authority on the doping control forms
- ➤ Ensuring that the correct discipline is recorded on the doping control form ie inline speed >1000m or 1000m or less.
- Ensuring that the doping ontrol forms are returned to WSK in 5 working days.

#### Technical Document for Sport Specific Analysis (TDSSA) Menu

All sports have a sport specific testing menu allocated by WADA. A specific testing menu will be mandated for the new disciplines effective 1 January 2018.
