COUNTRY QUOTA

Each country is entitled to a registration quota of 3 Men and 3 Women. The country quota can be used to register any athlete of the NF selection.

ADDITIONAL COUNTRY QUOTA

Additional Country Quota are nominally available to a maximum of 6 top ranked Skaters. The skater must be ranked 30 or higher in the World Skateboarding Ranking.

PARK SEEDING STRUCTURE

The Medalists of the Olympic Games Paris 2024 will be exempted from competing the Open Qualifier and will be pre-seeded directly into the next competition phase.

Each National Federation must confirm the participation of its Additional Country Quota and Pre-seeded Athletes within the World Skate Infinity Platform (browser version). **Please do not register Additional Country Quota and Pre-seeded Athletes within your Country Quota on your own, wait for them to be added and confirm (or not) their participation**

WORLD SKATEBOARDING RANKING

The World Skateboarding Ranking (WSR) is the version of the OWSR that World Skate keeps after the Paris 2024 Olympic Games and before the start of the next Olympic Qualification season. The WSR is going to be released after the confirmation of the country quotas of the Olympic Games.

WILD CARD REQUESTS

Athletes not otherwise eligible to compete may be granted a Wild Card by World Skate.

Please note that a Wild Card is granted at World Skate's discretion and is limited to the cases provided for in the "[World Skate By-Laws](#)".

A Wild Card may be granted in case of lack of an existing and recognized NGB in the country of the athlete's origin.

In the case of a Country in which there is a recognized NGB that does not include the relevant Sports into its activities the athletes shall mandatorily contact the relevant NGB for approval and clearance to compete for their respective Countries and under their own Anthem and Flag. Should the mentioned Federation not answer within 15 days, World Skate might allow the athlete concerned to compete under his/her Country Anthem and Flag.

Wild Card requests must be sent by e-mail to platform@worldskate.org by **August 1st 2024**.

ENTRY FEE

Each participating athlete will pay the following net fee: 200 USD. Pre-seeded skaters (Medalists of the Olympic Games Paris 2024) are exempted from paying the registration fee.

NATIONAL TEAM OFFICIALS

The NF are entitled to register a specific number of National Team Officials for their country.

National Team Officials: Max 5

Coach: 2

Team Manager: 1

Doctor: 1

Physiotherapist: 1

The National Federations (NFs) are entitled to register a specific number of National Team Officials, listed above. NFs with a large contingent of competing athletes may apply for additional National Team Officials quotas, pending approval by World Skate.

Moreover, each NF has the right to register its President and its Secretary General, one Chef de Mission, two Staff Members and one Media Manager.

MINOR'S PARENTS / LEGAL GUARDIANS

Minor's (U18) parents or legal guardians will be able to register to the event by clicking [here](#).

Only one legal guardian or parent per minor athlete can be registered.

Registration deadline is **August 5th 2024**.

The legal guardian/parent is expected to be present with their relevant athlete each day at their required registration time to sign documents.

Please note that providing your data and Passport in Infinity as a verification process for minor skaters' profile, does not guarantee/provide a credential for the event.

After completing the Form above, parents and legal guardians are required to sign up in Infinity and create a profile with all the information required: from [desktop](#) version (browser) or App Version (available on [Play Store \(Android\)](#) and [App Store \(iOS\)](#)). Parents and legal guardians must select "Other" as category when required during the registration process in Infinity.

Competition phases will be organized as follows:

Quarterfinals	3 Runs / Time until fall, Best run counts	4 heats of 8 skaters
Semifinals	3 Runs / Time until fall, Best run counts	2 heats of 8 skaters
Final	3 Runs / Time until fall, Best run counts	8 skaters

PRIZE MONEY

A total of \$250,000 USD will be allocated for Street World Championship 2024 and will be equally split between men and women.

ANTI-DOPING

The doping controls, the sample collection processes and the laboratory analysis will be conducted in accordance with the World Skate Anti-doping Rules, the WADA Code, the International Standards for Testing and Investigation (ISTI), incorporating the requirements of the Technical Document for Sport Specific Analysis (TDSSA), and following the instruction of the World Skate Anti-doping Manager/Delegate.

During the sign-up procedure to the Sports Registration System (World Skate Infinity, please see above), all athletes and staff members must upload a valid Anti-Doping Training Course Certificate. Those issued by WADA (through the Adel platform), ITA (International Testing Agency), National Anti-Doping Organizations and/or World Skate during 2022, 2023 and 2024 are accepted.

Should you need a new Anti-Doping Training Course Certificate, please visit the [WADA ADEL platform](#) and complete the relevant Course, according to your role.

We remind you that the [WADA ADEL platform](#) is not run by World Skate; therefore, should you have any issue in this regard, you will need to contact WADA's support directly.
