TOKYO 2020 QUALIFYING SYSTEM STATUS

We are very excited to announce that Dew Tour will be the first event of 2021 to resume the Olympic Qualification system after stoppage due to the COVID-19 pandemic.

This event will be classified as Pro Tour for both Street and Park disciplines.

An official communication about Street and Park World Championships will be published soon, but for a better organization of your travelling, we anticipate that the <u>Street World Championship</u> will be held in Rome, Italy from May 31st to June 6th.

COUNTRY QUOTA

National Federations are allowed to register **5 athletes** per gender and discipline. Pre-seeded skaters do not count against the Country Quota registration limit.

SEEDING STRUCTURE

The **TOP 12** ranked athletes in the <u>World Skate Ranking</u> (WSR), per gender and discipline, will be pre-seeded to the Semifinal round of competition.

Pre-seeded skaters to Semifinal are exempted from paying the registration fee and must check in at the competition by the following deadline:

• Thursday, May 20th at 03:00 pm

In case of no-show or inability to skate, Pre-seeded skaters will be replaced with the next ranked rider from the Open Qualifier.

- Skaters ranked from the <u>13th to 30th positions</u> of the World Skateboarding Ranking as of March 3rd, 2019 will compete at the **Open Qualifier**.
- Skaters, ranked <u>1st to 30th</u> are not required to be registered in the Sports Entry Platform. They don't count against the country quota. Their participation must be confirmed by the National Federation of belonging by responding an e-mail they will receive from <u>platform@worldskate.org</u>.

COMPETITION FORMAT

Street Open Qualifier - Best of 2 Runs

- 7 heats with a maximum of 18 athletes in men's and a maximum of 15 athletes in women's divisions
 - 45minute practice prior each heat
- Heats are based on World Skate Rankings in reverse order
- 2 Runs, 45 Seconds, best run counts
- Each run is scored out of a possible 100 points, with the use of 2 decimal numbers. 100 is the highest score
- Best 20 athletes advance to the semifinal

Street Semifinal and Final - Olympic Street Format (2/5/4)



- 2 runs & 5 tricks per athlete
- 3 heats consisting of 11, 11 and 10 athletes
- Heats' starting order is based on the following:
 - Open qualifier athletes (starting in reverse order)
 - Pre-seeded athletes (starting in reverse order)
- Each heat will run through 2 runs and 5 tricks, then move to practice for the next heat
 - 45minute practice prior each heat
 - 3 minutes for transition between run and trick attempts
- 2 45-second runs (all complete run 1, all complete run 2)
 - Each run is scored out of a possible 10 points with the use of 2 decimal numbers. 10 is the highest score
- 5 Trick attempts
 - Each trick attempt is scored out of a possible 10 points with the use of 2 decimal numbers. 10 is the highest score
 - Athletes can use any obstacle on the FOP multiple times
- Athlete's final score is based on the highest 4 scores out of 7 scores total (5 trick attempts and 2 runs)
- Best 8 athletes advance to the final
- Final round is held in the same format as the semifinal round
 - 60minute practice prior competition heat

Park Open Qualifier - Best of 2 Runs Format

- 7 heats with a maximum of 12 athletes per gender category
 - 45-minute practice prior each heat
- 2 runs, 40 seconds (total time does not stop if athlete falls), best run counts
- Heats are based on World Skate Rankings in reverse order
- Each run is scored out of a possible 100 points, with the use of 2 decimal numbers. 100 is the highest score
- Best 20 athletes advance to the semifinal

Park Semifinal - Best of 3 Runs Format

- 3 heats consisting of 11, 11 and 10 athletes
 - 60-minute practice prior each heat
- 3 runs, 40 seconds per run (a run is over if athlete falls before the expiration of the 40 second time limit), best run counts
- Heats' starting order is based on the following:
 - Open qualifier athletes (starting in reverse order)



- Pre-seeded athletes (starting in reverse order)
- Each run is scored out of a possible 100 points, with the use of 2 decimal numbers. 100 is the highest score
- Best 8 athletes advance to the final

Park Final - Best of 4 Runs Format

- 1 heat of 8 semifinal athletes starting in reverse order
 - 60-minute practice prior each heat
- 4 runs, 40 seconds per run (run is over if athlete falls before 40 seconds), best run counts
- Each run is scored out of a possible 100 points, with the use of 2 decimal numbers. 100 is the highest score

REGISTRATION

Registration will take place through the online World Skate Sports Entry Platform.

The platform will open on March 18th at 00:00 am (CET) and will close on April 7th at 11.59 pm (CET).

Due to COVID-19 regulations on international and domestic traveling, venue logistics and event organization, World Skate and the Organizers require the registration of <u>essential National Team Staff only</u>.

EVENT WILDCARDS

A limited number of Wildcards may be granted based on host country quota or lack of an existing and recognized NGB in the country of the skater's origin. Wild Cards will be issued at the sole discretion of World Skate and following the World Skate Competition Rules.

All potential Wildcards must be free of sanctions and must be applied by sending an e-mail to platform@worldskate.org, before **April 7**th **at 11.59 PM CET**.



COVID RISK MITIGATION PROVISIONS

Together with the organizers and WMI Global, we are finalizing COVID-19 risk mitigation protocols to ensure the safety and health of all participating athletes and staff. We will share this with you soon with Bulletin 02.

ANTI-DOPING

The anti-doping control will be carried out according to World Skate Medical Regulations and WADA Rules.

Anti-Doping forms will be required for both athletes and staff members. Same applies to preseded riders.

All athletes and staff members must complete the Athletes/NTOs section online, including uploading a valid Anti-Doping Training Course Certificate, in the World Skate Platform: http://platform.worldskate.org/web/

Upon completion of the abovementioned procedure, National Federations will be enabled to register respective athletes and staff members.

VISA

Regarding VISA requests, we invite you to check the Visa Application Form for Sport Events with the embassy of your Country.

Please note that invitation letters can be issued only after performing the registration on World Skate Sports Entry Platform.

Under the host country border protection regulation, athletes from everywhere can enter the US if they are competing in an event, like Dew Tour, if they are granted a National Interest Exemption (NIE) waiver.



NATIONAL INTEREST EXEMPTION (NIE) WAIVER

To prevent the spread of COVID-19, President Biden issued Geographic Presidential Proclamations suspending the entry to the United States of foreign nationals, regardless of citizenship, who have had a physical presence in a restricted nation at any point in the 14 days before their arrival. Foreign nationals (excluding legal permanent residents) may not enter without receiving a National Interest Exemption 212(f) waiver from the Department of Homeland Security. The following countries are restricted:

Africa: South Africa Asia/Middle East: China and Iran Europe: Austria, Belgium, Czech Republic, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, Switzerland, and the U.K. South America: Brazil

Note: Transit through any of the listed nations (ex: flight lay-over) constitutes as having a physical presence.

<u>U.S. Olympic & Paralympic Committee National Interest Exemption for Events and Training</u>

On August 11, 2020, DHS issued a National Interest Exemption notice to the USOPC for international athletes, essential staff, and their dependents participating in senior-level international competitions and training. On January 25, 2021, President Biden's administration extended the National Interest Exemption 212(f) waiver. The Government Relations office is facilitating the waivers through U.S. Customs and Border Protection.

Instructions for National Federations

- 1. Complete the waiver request spreadsheet you can find as Annex 1 (Green sections only Columns A-M, you can leave column G blank) for each traveler(s) on or before April 7th, 2021. Note: if the traveler(s) need to secure a visa, please note that in the email when you send back the completed spreadsheet. This is important as those who need a visa will be processed first as sometimes having the NIE request in helps expedite the visa process (however traveler(s) should still start the visa process ASAP to ensure processing). Send the completed request to sarah@snowparktech.com.
- 2. They will notify you of the waiver status. When clearance is granted, they will provide a confirmation letter as evidence of a 212(f) waiver.
- 3. Advise the traveler(s) to check the information on the U.S. Embassy website in the country where they reside. Each embassy may have specific instructions for individuals to travel on a National Interest Exemption. If asked, the traveler(s) should provide the USOPC waiver confirmation letter.



Additional Information:

- An individual's role at an event must be clearly defined (i.e., Athlete, Coach, Trainer, etc.) certain support staff may be reviewed on a case-by-case basis. Only essential staff will be approved.
- Travelers must agree to follow the Center for Disease Control and Prevention (CDC)
 protocols upon arrival in the U.S., to include quarantine. Please find the CDC's
 protocols here: https://www.cdc.gov/coronavirus/2019-ncov/travelers/after-travel-precautions.html
- Waivers are valid for 30 days from the date of issuance and for single-entry into the United States, subject to change. The purpose of the trip must relate to the NGB/event organizer.
- The waiver, if granted, does not exempt travelers from inspection by U.S. Customs and Border Protection or exempt them from standard entry requirements, including visa, passport, and any other necessary documentation requirements.
