## TOKYO 2020 QUALIFYING SYSTEM STATUS

---

We are very pleased to announce that the Street World Championship 2021 will be held in Rome, Italy, from Sunday, May 30<sup>th</sup> to Sunday, June 6<sup>th</sup>, 2021.

This Event will be classified as World Championship, the top tier of Olympic qualification point earning competitions.

The 6 (six) highest placed athletes (top 3 women, top 3 men) will be directly qualified to participate in the **Olympic Games** regardless of their placings on the Olympic World Skateboarding Rankings as of 30 June 2021.

## COVID RISK MITIGATION PROVISIONS

---

Being the athletes, judges and all the staff working in the event, the absolute priority for World Skate, together with the Medical Commission and WMI we have created the following COVID-19 Protocol which will be applied at the event in order to guarantee all parties are healthy and safe.

**More details about venue access and protocols will be shared after the registration is closed, once they are delimited together with the local authorities, organizers and the medical agency.**

## VISA

---

Regarding VISA requests, we recommend you to check “Visas by Invitation” (*V.S.U. - Visto per Invito*) with the Italian embassy/consulate of your country.

We invite you to check the opening times and slot availability of the embassy/consulate of your country and to consider booking an appointment in advance as the process might be slower than usual due to the pandemic situation.

**Please note that invitation letters can be issued only after performing the registration on World Skate Sports Entry Platform. No exceptions can be made.**

Should you need to request an invitation letter to apply for your Visa, please fill out [Annex 1](#) with all the required information and submit the document to: [skateboarding@fisr.it](mailto:skateboarding@fisr.it) and [operations@worldskate.org](mailto:operations@worldskate.org).

Please make sure that the information you submit is precise and accurate and, in the case of any changes in your plans, you must promptly communicate them to the same email addresses as per the Italian laws and regulations.

If you participate in the Dew Tour event prior to the World Championship in Rome (without going back to your country) and you need a visa to enter into Italy, please register for the Street World Championships through the Sports Entry Platform and submit Annex 1 as soon as possible.

Under the host country border protection regulation mentioned under article 18, paragraph 1 of PMD of March 2 2021, athletes and essential staff can enter Italy from all countries-irrespective of their travel history- if they are competing in an event recognized by the Italian Olympic Committee, such as the World Championships.

According to Article 51, paragraph 7 of PMD of March 2, 2021, provided that the persons travelling to Italy do not show any COVID-19 symptoms, the medical supervision and self-isolation do not apply to persons entering the Country in connection with sports events and competitions of national interest organized in accordance with ad hoc protocol adopted by the organizer of the event. Athletes and essential staff will not be subjected to quarantine or self-isolation if the following mandatory requirements and documents are presented:

1. They must fill out a self-declaration form ([Annex 2\\_Self Declaration](#)) and carry it with them upon arrival into Italy and throughout the entire duration of the event.
2. They must carry with them a certificate proving that they have taken a molecular or antigenic test carried out by means of a swab, **in the 48 hours before entering into Italy**, with negative results.
3. They must print out the official letter of participation for the event that will be sent to the email address of the Team Manager registered on the Sports Entry Platform. Each NGBs will receive a copy as well. The Team Manager will be in charge of forwarding the letters to all the registered persons. All registered persons must carry this letter with them upon arrival into Italy and throughout the entire duration of the event.
4. Sporting events must take place in accordance with relevant health and safety protocols adopted by the organization responsible for the event.

**Please also check the regulations of your country should you need any travel and/or health insurance to travel into Italy.**

Please note that if you do not present all the above-mentioned documents and requirements, there is no guarantee that you will be exempted from quarantine upon arrival into Italy.

During your stay in Italy, should any flu-like symptoms compatible with COVID-19 arise, you must report it immediately to the local Health Authority, by calling dedicated local numbers. While waiting for further Health Authority decisions, you must put yourself in self-isolation. Please also check the regulations of your country should you need any travel insurance to travel into Italy.

## COUNTRY QUOTA

---

National Federations are allowed to register **5 athletes** per gender.  
Pre-seeded skaters do not count against the Country Quota registration limit.

## SEEDING STRUCTURE

---

The TOP 5 ranked athletes in the [World Skate Ranking](#) (WSR) as of Monday, May 24<sup>th</sup> (after Dew Tour), will be pre-seeded to the Semifinal round of competition.

Pre-seeded skaters to Semifinal are exempted from paying the registration fee and must check in at the competition by the following deadline:

- June 2nd 2021 at 03:00 pm

**In case of no-show or inability to skate, Pre-seeded skaters will be replaced with the next ranked rider from the Open Qualifier.**

- Athletes ranked from the 6th to 30th positions of the World Skateboarding Ranking as of today will compete at the Open Qualifier.
- Athletes ranked 1st to 30th are not required to be registered in the Sports Entry Platform. They don't count against the country quota. Their participation must be confirmed by the National Federation of belonging by responding to an email they will receive from [platform@worldskate.org](mailto:platform@worldskate.org).

## COMPETITION FORMAT

---

The **Qualifier** round of competition comprises the following athletes:

- Country Quota Athletes, 5 per gender and discipline per each NGB
- Athletes ranked 6<sup>th</sup> to 30<sup>th</sup> in the WSR
- Wild Card Athletes

The **Semifinal** round of competition comprises a total of 32 athletes.

- Pre-seeded Athletes: Ranked 1<sup>st</sup> to 5<sup>th</sup> in the WSR
- Top 27 ranked athletes advancing from the Qualifier round (minimum)
- The best 8 athletes of the Semifinal will advance to the **Final**.

## REGISTRATION

---

Registration will take place through the online World Skate Sports Entry Platform.

The platform will open on **April 2<sup>nd</sup>** at **00:00 am (CET)** and will close on **April 21<sup>st</sup>** at **11.59 pm (CET)**.

**Due to COVID-19 regulations on international and domestic traveling, venue logistics and event organization, World Skate and the Organizers require the registration of essential National Team Staff only.**

A limited number of Wildcards may be granted based on host country quota or lack of an existing and recognized NGB in the country of the skater's origin. Wild Cards will be issued at the sole discretion of World Skate and following the World Skate Competition Rules.

All potential Wildcards must be free of sanctions and must be applied by sending an e-mail to [platform@worldskate.org](mailto:platform@worldskate.org), before **April 21st at 11.59 PM CET.**

## MINORS PARENTS / LEGAL GUARDIANS

---

Minor's (U18) parents or legal guardians will be considered as essential staff and will be able to register to the event, but this is not mandatory.

Only **one legal guardian or parent** per a minor athlete can be registered.

Legal guardians/parents must send an email to [platform@worldskate.org](mailto:platform@worldskate.org) to register and once they've completed this step, they can follow the procedure explained above to obtain the Visa if needed.

Registration deadline is **April 21<sup>st</sup>.**

The legal guardian/parent is expected to be present with athlete each day at their required registration time to sign documents, verify health assessment and sign testing consent form (on testing days).

Given the World Skate COVID-19 protocol and restrictions, the access to the venue is not guaranteed. More details will be published soon.

## ACCOMMODATION AND LOGISTICS

---

Hotel information will be shared shortly. Together with the organizers we are finalizing the protocols to follow regarding the accommodation and logistics. We will share this information as soon as possible.

## ANTI-DOPING

---

The anti-doping control will be carried out according to World Skate Medical Regulations and WADA Rules.

Anti-Doping forms will be required for both athletes and staff members. Same applies to pre-seeded riders.

All athletes and staff members must complete the Athletes/NTOs section online, including uploading a valid Anti-Doping Training Course Certificate, in the World Skate Platform: <http://platform.worldskate.org/web/>


