## **SCHEDULE**

Dear Sirs,

We are pleased to announce that on Saturday 5<sup>th</sup> November 2022 in Buenos Aires, Argentina, in occasion of the World Skate Games, it will be organized an Examination Session for those national speed judges wishing to access an international level.

- Theoretical Examination: Saturday 5<sup>th</sup> November
- Practical Examination: Sunday 6<sup>th</sup> November

Examination details will be directly informed to the registered candidates.

## **REQUIREMENTS**

According to the TC Regulations, art. 19:

World Skate organizes the examination of the Jury with the support of the Technical Commission.

Each candidate must have officiated at least for two (2) years at the maximum category in his country. Such candidates must be fluent in the official language of World Skate: English.

#### **EXAM STRUCTURE**

A Technical Commission member and an experienced International Judge will examine proposed candidates, as follows:

Two (2) hours of written test of about the knowledge of the Inline Speed Technical Regulations.

Oral test of twenty (20) minutes about the knowledge of the inline speed skating sport. The capacity to understand and speak the official language (English) is evaluated.

Candidates who succeed the World Skate two (2) tests will be observed and evaluated in their capacity as judge in the different tasks of the Jury.



Candidates who pass such exams will be registered International Judges and can be convened for international competitions.

Candidates who succeed this examination must attend the Judges' Academy Seminar 2023, to validate their international category as per the TC Rulebook articles 17 & 26.

The fee for the inscription at the International Judge examination is 100 USD.
