IWGA - WORLD SKATE COMMITMENT

As per the Official IWGA Commitment for Speed Skating, the Organization will provide the sixty (60) Athletes quota with free accommodation, catering and local transport.

EXTRA TEAM OFFICIALS

Extra Team Officials are Coaches, Medical staff, Team manager. For the Speed Skating discipline at TWG, each country is allowed to register Extra Team Officials according to their number of qualified Athletes. The details numbers will be informed in the next bulletin. The expenses are to be covered by the corresponding country (NF, NOC, NSO). REGISTRATION DATES AND MODALITY UPDATES

Athletes & Extra Team Officials

Each qualified National Team must submit their athletes' names not later than March 30th 2025, to sportsdepartment@worldskate.org

Per person, this submission shall include emergency contact name (and emergency contact phone number), if a visa is required, special dietary needs if any (Halal Kosher, Vegan, Vegetarian or Other -specify-), employer and job title.

Please, make sure that all the Athletes and Team Official, and Extra Team Officials have their World Skate Infinity platform profile updated, including their phone number, email address, passport good quality photo/scan and that their personal photo meets the following criteria:

- Colour photo taken within the last 6 months
- White background
- It must be in color with sharp focus and good contrast
- It must be taken directly from the front, against a light background
- Eyes must be open and clearly visible with no hair or tinted glass across the eyes
- No headgear is permitted, unless religious headgear if chin, forehead and cheeks are clearly visible and if it does not cast a shadow on the face

Registration Process Phases

- Phase 1

Current phase: Countries Athletes List report to the World Skate Sports Department, before March 30th. World Skate uploads the athletes names to the IGMS System -it becomes public on the following [LINK](#)- and to the EMS (Event Management System).

Countries Extra Team Officials list report to the World Skate Sports Department. not later than April 15th. This information will be uploaded to the EMS.

- Phase 2

Sport Entries and Athletes Additional Data & Short List selection

Athlete's Additional Data and Sports Data collection will be followed up with the concerned countries, they will be contacted by the Sports Department, not later than May 15th.

In the case of an injury or the impossibility to attend TWG, an Athlete can be replaced in this phase.

- Phase 3

Consent Forms and Data Privacy Policy Approval by 30 July 2025.

PARTICIPANT COUNTRY SPONSOR LOGOS INFORMATION

Any TWG participant who wishes to display sponsors' logos on their personal equipment or clothing must submit a request for approval for each sponsor and logo to the LOC, except for the manufacturer. MAJOR CHANGES COMPARED TO TWG 2022

- participating athletes, medical personnel and one team official (coach) in team sports are required to complete WADA's Anti-Doping Education and Learning (ADEL) course or other WADA approved courses in order to receive their accreditations and participate in The World Games.

- The IWGA will offer the possibility to athletes with babies, up to the age of 18 months at the day of the Opening Ceremonies of The World Games 2025 (7 August 2025, therefore born after 6 February 2024) to be accredited and housed together with the parent athlete and to be accompanied by a caregiver during the Games. Athletes participating in The World Games 2025 should register their intent through the IWGA Athletes Committee by 30 April 2025 at the latest.

INSURANCE REMINDER

All participants, including athletes and officials representing your federation, must possess a valid private health and repatriation insurance in accordance with the Rules of The World Games.

This insurance must mandatorily cover the following:

- Accidental medical treatment, sudden illness, and hospitalization allowance.
- Repatriation costs in emergencies requiring a return to your place of departure.

Participants are required to purchase the adequate insurance prior to their departure and provide a valid insurance certificate upon arrival in Chengdu as part of the accreditation process.

Important:

Any participant failing to present their insurance certificate or not meeting the minimum required coverage will not be allowed to participate in The World Games 2025.

World Skate, the Chengdu ExCo and IWGA will not be held liable for any risks, denial, costs or loss arising from a lack of adequate insurance.

We kindly request all National Federations to ensure compliance with these requirements, communicate this information to your athletes and officials at the earliest opportunity and inform World Skate about the compliance of this requisite.

ANTIDOPING

The doping controls, the sample collection process and the laboratory analysis will be conducted in accordance with the IWGA's Antidoping Rules, the WADA Code and the International Standards for Testing and Investigation.

According to IWGA's Anti-Doping Rules, participating athletes, medical personnel and one team official (coach) in team sports are required to complete WADA's Anti-Doping Education and Learning (ADEL) course or other WADA approved courses in order to receive their accreditations and participate in The World Games.

The following courses are recommended by WADA:

- For athletes: ADEL for International Level Athletes (ILA) (25 languages) or ADEL for Talented Athletes (TA) Competed at Major Events (Youth athletes, English, French,

- Spanish)
- For Coaches: ADEL for Coaches of High-Performance athletes (12 languages)
 - For Medical Professionals: ADEL for Medical Professionals at Major Games (English, French, Spanish, Bulgarian, Croatian, Portuguese, Romanian, Russian, Ukrainian)


