## IMMIGRATION REGULATION AND ENTRY VISAS

The Ministry of Interior through the National Immigration Directorate is the implementing authority and is responsible for setting and administering the rules and the general policy guidelines for residence and migration.

In accordance with the National Constitution, visitors and Argentine citizens alike have equal rights. This extends the access to health services and social assistance, due process and deference in trial and free legal aid.

Entry to Argentina is conditional on holding a valid visa for at least six (6) months from the date of arrival and for the period of stay and must contain blank page(s) migration stamps.

Visitors may stay in Argentina for 90 days, the period can be extended for an equal period. For longer periods, a residence visa is required.

Visitors requiring a visa to visit or stay in Argentina may apply for it at the Argentine consulate or embassy in their country of residence.



Arrivals and Departures service from/to the airport to/from the respective hotels according to flight details.




**Ezeiza International Airport (EZE)**, 22 km south of the city, is Argentina’s largest and it will be the **Official Port of Entry** for World Skate Argentina 2022.

Access to Ezeiza is via from Buenos Aires is via the Richieri Highway, which connects with the city’s major arterial routes and avenues. Travel time is only 36 minutes.

A second airport, along the banks of the Rio de la Plata, is the International Metropolitan airport “Aeroparque Jorge Newbery” (AEP), which will be the connecting airport with San Juan.

The airport of San Juan, Domingo Faustino Sarmiento (UAQ), is located in the town of Las Chacritas, 15 km and southeast of the center of the city of San Juan. It operates domestic flights, mainly with Aeroparque. Travel time to the downtown of San Juan is only 20 minutes.

## COVID- 19 PROTOCOL

---

Argentines, Argentines and residents of the country must:  
Complete the Affidavit at least 48 hours before the trip.

Those who enter the country for a period of less than 24 hours will be exempted and do so by land.

Non-resident foreigners must:  
Complete the Affidavit at least 48 hours before the trip.

Present COVID-19 health insurance (Coverage of hospitalization, isolation and / or health transfer services).

Those who enter the country for a period of less than 24 hours will be exempted and do so by land.

Those non-resident foreigners of Ukrainian nationality or from that country, while they remain in a transitory migratory situation, must have COVID-19 health insurance if they do not have any other type of health coverage.

People who have an incomplete vaccination schedule are recommended to have a

diagnostic test within 24 hours of their entry into the country.

If a positive or suspected case of COVID 19 is detected or reported at the point of entry, The Contingency Plan of that Point of Entry will be activated.

No PCR or antigen-negative test is required for admission if you have a complete vaccination schedule.

What does “**complete vaccination**” mean?

Currently, “complete vaccination”; is considered to be a schedule of TWO doses administered with an interval of 14 days or more since the last dose was administered. A vaccination is also complete in the case of single-dose vaccines, such as the Cansino vaccine, when 14 days or more have elapsed since its application.

Those who do not have the complete scheme according to the criteria of the Ministry of Health of the Argentine Republic, must enter with a PCR or antigen test within 24 hours after entering the country.

Medical Insurance must clearly state in writing on the voucher that it has coverage for COVID-19 (Coverage of hospitalisation, isolation and/or sanitary transfer services).

The event does not require any type of quick test for accommodation or accreditation, nor the use of masks in the training, warm-up and competition areas.
